Work with the City to establish a means, method, and plan to repair the OHHA Streets.

- a. Assessment Survey
 - 1. In response to a City "next step" request, survey property owners to establish interest and willingness to pay the proposed assessment for the streets.
 - a. City goal is 70% response.
 - b. Develop plan to for final canvas of neighborhood/contact non-resident property owners to obtain outstanding surveys.
 - c. Final push/surveys into Jerry April 7, 2019.
 - d. Submit results to City end of May, 2019.
- b. Next Steps/Timeline
 - 1. Private Street Transfer City provide deed transfer paperwork for any deeds in question. OHHA will present to homeowners for transfer TBD
 - 2. Finalize Cost Projections, City perform Engineering Spring 2019
 - 3. Vote to form an assessment district Summer 2019
 - 4. OHHA and City Sign Formal Contract Summer 2019
