Current Business

- 6. Streets! (Bob)
 - a. 2021 Cotati/Tribune
 - 1. Traffic Markings Neighbors indicated increase in vehicles going the wrong way on Hillcrest, Parkside, and Call. Includes neighbors, delivery vehicles, and garbage trucks.
 - In conjunction with 2022 Paving, City will enhance street marking and signage (striping and reflectors) as appropriate.
 - 2. Tribune Traffic Calming Petition submitted (Jan 12, 2022) and rejected (Mar 14, 2022). Based on speed measurement taken near the top of Tribune and "no accidents over the last 5 years." City advises that data does not support traffic calming. In conjunction with the Villas HOA, requested that speed measurement be taken closer to Hayward Boulevard. Also advised City that there have been at least 2 reported accidents within the past 3 years and a number of pedestrian near misses. According to City, Tribune will never qualify for any physical speeding impediments.
 - Re-survey taken closer to Hayward Boulevard mid Aug. Awaiting results.
 - If results indicate data more supportive of further action, City will install a speed radar feedback sign. The city is also willing to place additional speed graphics on the street.
 - If observe speeding or are a victim of a near miss, please submit an Access Hayward to record the incident.
 - Meeting tomorrow with City to find out whether calming deterrents will be provided.
 - b. 2022 Grandview/Campus View/New Dobbel
 - 1. Design and Requirements
 - City investigating existing infrastructure that may be incorporated into paving project.

- Walked down streets with City project manager and site inspector, and contractor on Oct 12, 2022.
- Discussion of concern regarding how narrow Cotati becomes, and how the current width will be maintained.
- Need to provide notification, Notice of Work, from City to forward to the property owners.
- 2. Grandview Illegal Parking Impediments

City and OHHA will work with CSUEB to renew/upgrade illegal parking impediments along Its property on Grandview.

- Lots of obstructing timber is not solution to obstruct parking.

- 2. Impact of Easements
 - City started survey and easement effort on Call/Chronicle.
- d. Drainage

City to research existing storm drain system in each section; potentially (no commitment) add storm drain inlets to aid in runoff control where possible. OHHA to urge City to maintain the drainage systems.

e. DIA and Executed Easements

OHHA to confirm with City plan and timing of filing executed easements and release of DIAs with County.

1. City paving project manager working with City Attorney to develop process. Get DIAs release and fully executed easements.

7. Switzer and Fan Construction

Construction starts and impacts to Streets and Neighborhood

- b. Fan –Additional revisions required before City approve their Site Plan Review application.
 - City issued a "final" notification. It also clarified that postcard cartoon sent with the
 notification did <u>not</u> correctly represent the current approved height of the structure. City
 will provide final plan to show correct configuration. Utility sewers to be installed prior to
 paving streets.
