Work with the City to establish a means, method, and plan to repair the OHHA Streets.

a. Bob presented update:

City to soon send to property owners the notice for the First Public Hearing for the formation of the assessment district. Hearing will occur at the Oct 20, 2020, City Council Meeting. (Board working with the City to finalize the notice.)

If the City Council votes to move forward with the process of establishing the assessment district, a Second Public Hearing will be scheduled. Property owners will receive another notice with the date of the Second Public Hearing and information regarding assessment district details, and an official ballot for voting on the assessment and instructions for the voting process. This notice will be mailed at least 45 days prior to the date of the Second Public Hearing.
